This crystalline, feminine sparkler with notes of fresh red fruit pairs very well with chicken, charcuterie, pasta dishes and salads. It is produced from vines planted between 1980-1990, located within the **Paredes do Bairro** area of the **Beira Atlântico** wine region at 80m (262') elevation, growing in **clay and limestone** soil. Average temperature during the April-October growing season is 14° C (57.2° F); annual rainfall is 1,200mm (47.25"). It is aged for **3 months in bottle, 100% unoaked.**
