**60% MERENZAO, 30% MENCIA, 10% GARNACHA TINTORERA**  
 ESCALADA DO SIL is produced from vines planted between 1993 with a small part of Mencia and Garnacha over 100 years old. The vineyards are located within the **Valdeorras** wine region (Zone 1) at 500-750m (1,640 – 2,460') elevation, growing in **clay and granite** soil. Average temperature during the April-October growing season is 19° C (66.2° F); annual rainfall is 700mm (27.56"). It is aged for **15 months in 500L barrels**.
