Average temperature during the April-October growing season is 17°C (62.6°F); annual rainfall is 400mm (15.75"). It is **aged 4 months in French oak**. 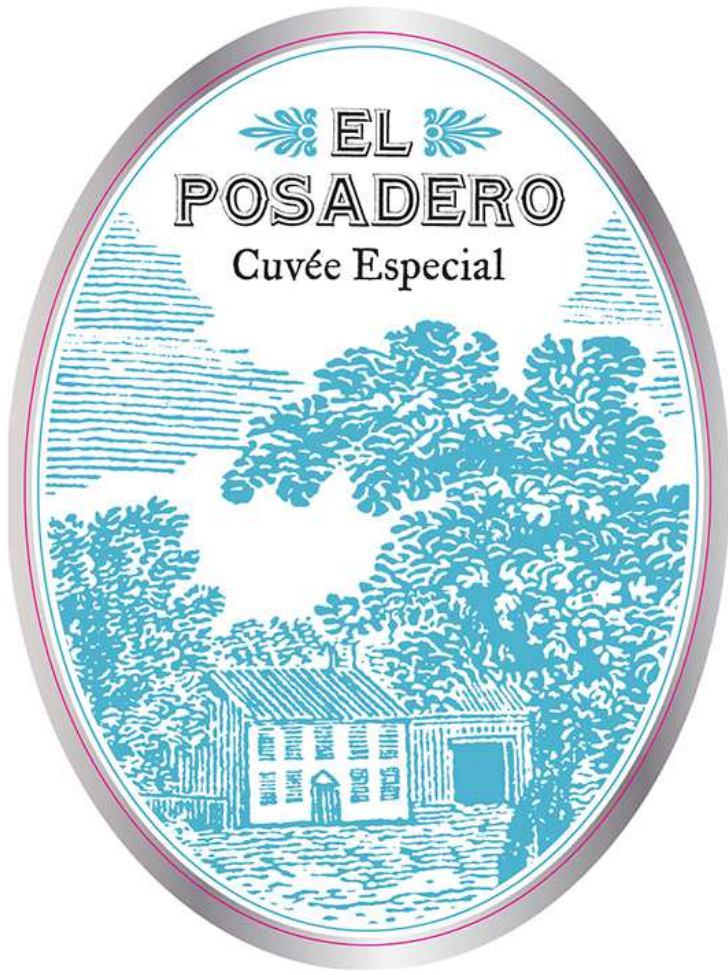
